GOLDEN VISA APPROVED

This former commercial building has been transformed into a residential development, making its apartments eligible for the Greek Golden Visa at the €250,000 investment threshold, in accordance with the latest regulations.

ADVANTAGES

- No requirement to reside in Greece
- Residence permits can be acquired within 90 days
- Unlimited expiry date of residence permit
- Opportunity to rent out the investment property
- Eligibility to apply for citizenship after seven years of residence
- Ability to hold shares and receive income from the dividends of a company registered in Greece (but not to be employed in Greece)

ELIGIBILITY

The residency is applicable to the applicant's whole family:

- Married spouse
- Children up to 24 years old
- Parents of the main applicant
- Parents of the spouse.
